### **Main Purpose**

We are currently seeking a highly skilled and motivated individual to join a premier team of Automotive Mechanics at 420 Air Base Squadron, Royal Air Force Fairford, United Kingdom.

The primary purpose of this position is to troubleshoot, maintain, repair, and overhaul complex major components and systems of combustion-powered automotive vehicles, electric-powered vehicles and equipment, towed vehicles and equipment, over-the-road trucks, and comparable vehicles.

The incumbent will:

- Troubleshoot defects and diagnoses malfunctions.
- Maintain, repair, and/or overhaul complex major components and systems. Interprets and applies manufacturers' repair manuals and technical specifications, schematics, engineering drawings, diagnostic codes, computer printouts and environmental and safety manuals.
- Utilizes safety practices and procedures following established safety rules and regulations and maintains safe and clean work environment.

### **Knowledge and Experience Required**

*Applicants must demonstrate the following:*

1. Must have NVQ Level 3 Light Vehicle Maintenance and Repair or Equivalent (Please submit copy with your application form)
2. Knowledge of safety regulations, procedures, and policies to include environmental directives pertaining to handling hazardous materials.
3. Knowledge of equipment common to the trade, i.e., front-end alignment and wheel balancing equipment, turning and grinding equipment for servicing brake drums and discs or rotor assemblies, and drilling and pressure bleeding devices.
4. Knowledge of technical practices in order to repair and/or overhaul major components and systems such as engines, transmissions, differentials, transaxles, electronic fuel injection systems, emission control systems, and related electrical, electronic, hydraulic, fuel, and other assemblies.
5. Skill in the use of measuring instruments and test equipment, i.e., computerized engine analyzers, compression testers, test benches, oscilloscopes, multimeters, special feeler and dial gauges, etc.
6. Skill in troubleshooting defects and diagnosing malfunctions and determining the kind and extent of maintenance and/or repairs needed.
7. Skill in using hand and power tools common to the occupation, i.e., wrenches, screwdrivers, insulated pliers, electric drills, pneumatic wrenches, and soldering irons.
8. Ability to interpret and apply manufacturers' repair manuals and technical specifications, schematics, engineering drawings, diagnostic codes, computer printouts, and safety manuals.
9. Ability to maintain, repair, and overhaul complex major components and systems in combustion-powered automotive vehicles, electric-powered vehicles and equipment, towed vehicles and equipment, over-the road trucks, and comparable vehicles without more than normal supervision.

### **Other Important Information**

- Must obtain and maintain the appropriate security clearance.
- May be assigned other duties that are appropriate to the grade and skill set of the employee.
- May be required to travel by military and/or civilian aircraft in the performance of official duties or attend necessary training. Position may be coded as mission essential.
- A 6-month probationary period will be required.
- Overtime may be required.
- May be required to travel overnight to US or other countries in the performance of official duties or attend necessary training.

### **Other significant facts pertaining to this position are:**

1. May be required to operate any of the vehicles managed by the Vehicle Fleet Section. This includes military and commercial designed light passenger vehicles, trucks, buses, tractors with semi-trailer up to 45 tons (Class 1), recovery vehicles and material handling equipment (MHE) up to 22,000 lbs.
2. May be required to guide and/or train lower graded employees.
3. The work may require the employee to drive a motor vehicle. An appropriate, **LGV CAT C** or **PVC CAT D** valid driver's license may be required for the position. (Please submit copy with your application form)
4. May be required to perform extended hours, on-call duties and shift working. Incumbent will be required to be in an on-call status outside normal duty hours or on holidays. Employee may be required to facilitate an on-call function over a 24-hour period covering 7 days a week as per the manning roster. An on-call allowance of £16.00 per day will be paid for each day that you are required to be in an on-call status.
5. Position requires adherence to procedures as prescribed in USAF Regulations, British Highway Codes, and local operating policies.
6. The Local National Direct Hire (LNDH) Program does not participate in regular drug testing, however positions covered by this SCPD may be subject to drug testing upon reasonable suspicion of substance abuse, and safety mishap or accident testing.
