
Initial Mandatory Supervisory Training



Experienced supervisors that have completed in-resident PME in the last 5-years receive an equivalency for the USAF Supervisors Course. and the Advanced **USAF** Supervisors Course. There is no equivalency credit granted for CPMC. MPMC is not required for prior AF military personnel who have retired within the last 5 years.



Complete course during 3rd year after completing last mandatory initial supervisory course and every 3-years thereafter.

IMST: Initial Mandatory Supervisory Training is required for new supervisors to be completed within 6-months of assignment. **Experienced Supervisor:** This is a supervisor with 3 or more years of supervisory experience. This supervisor could be exempt or offered to take a challenge exam to achieve an equivalency.

USAF Supervisor's Course: This course covers the communication, developing others, team building, conflict management, and leadership competencies of a supervisor. It is delivered on-line over a 5-week period of time with about 8-hours of class work/meetings per week. Those with in-resident PME within 5-years are exempt and earn an equivalency.

Civilian Personnel Management Course: This course covers the key issues a new supervisor needs concerning labor and employee relations, position management and the other key civilian personnel policies. It is delivered over a 3-week period of time with 8-hours of class work/meetings per week. Supervisors with 3+ years of experience supervising civilians can take a challenge test, and if they pass with 80% proficiency, gain an equivalency.

Military Personnel Management Course: This course covers the key issues a new supervisor of AF military personnel needs to know concerning promotions, performance management, customs/courtesies, and other key military personnel policies. It is delivered over a 4-week period of time with 4-hours of class work/meetings per week. Air Force military personnel and those who are retired AF within the past 5-years are exempted and gain an equivalency. Supervisors with 3+ years of experience supervising AF military personnel can take a challenge assessment, and if pass with 80% proficiency, gain an equivalency.

Advanced USAF Supervisor's Course: This course covers the basic supervisory skills in an advanced manner for supervisors that have had at least 3 years experience supervising military or civilian personnel. Those with prior military service/in-resident PME within 5-years are exempt.

CPMC Challenge: Experienced supervisors of at least 3 years will be asked if they would like to take a challenge assessment in Orientation. If they demonstrate 80% or greater proficiency on this assessment, they will be granted a CPMC equivalency. Students who pass the challenge assessment can still down load the CPMC course material, Civilian Personnel Handbook, and attend class if they like.

MPMC Challenge: If it is greater than 5-years since a person has retired from the AF, they will be offered a challenge assessment during Orientation. If the student passes with 80%, they will be awarded an equivalency. Students who pass the challenge assessment can still down load the MPMC course material and attend class if they like.

Refresher Supervisory Course: Supervisors will refresh their skills with this 1-week, 4-hrs per day course every three years.
