4. Team Mildenhall will identify and implement feasible, economically justified options to prevent or minimize pollution and increase resource conservation while conducting the mission.
5. The protection of our environment, like the safety of our Airmen, depends on the behavior and decisions that each of us make every day. It is therefore the responsibility of all Airmen working for or on behalf of Team Mildenhall, whether contractor, civilian, or military, commander or newly enlisted, to comply with this policy.
