



# Don't let this happen to YOU!

## ARTICLE 15s

**Staff Sergeant: Dereliction of Duty, Willful.**  
Received a suspended reduction to E-4, forfeitures of \$1,225 for two months, 30 days extra duty and a reprimand for willful dereliction of duty.

**Staff Sergeant: Dereliction of Duty; Violation of an Order.**  
Received a reduction to E-4, suspended forfeitures of \$1,225 for two months, suspended 14 days extra duty and a reprimand for violating a general order.

**Senior Airman: Abusive Sexual Contact.**  
Received a reduction to E-3, suspended forfeitures of \$969 for two months, suspended 30 days extra duty and a reprimand for abusive sexual contact.

**Senior Airman: Drunk driving.**  
Received a reduction to E-3, suspended forfeitures of \$300 for two months, 15 days extra duty and a reprimand for drunk driving.

**Airman First Class: Dereliction.**  
Received a reduction to E-2 with a suspended reduction to E-1, 30 days extra duty and a reprimand for dereliction of duty.

**Staff Sergeant: Assault; Drunk and Disorderly; Violation of an Order.**  
Received a suspended reduction to E-4, forfeitures of \$310 for two months, 45 days extra duty and a reprimand for assault, drunk and disorderly, and violation of an order.

**Senior Airman: Disobeying an NCO.**  
Received a suspended reduction to E-3 and a reprimand for disobeying an NCO.

**Senior Airman: Damage to Military Property.**  
Received a suspended reduction to E-3, forfeitures of \$500 for one month, 15 days restriction to base, 30 days extra duty and a reprimand for destruction of military property.

**Airman First Class: Misbehavior of a Sentinel x2.**  
Received a reduction to E-2, suspended forfeitures of \$867 for one month, 14 days extra duty and a reprimand for sleeping on post two times.

**Airman First Class: Drunk and Disorderly; Unlawful Entry.**  
Received a reduction to E-2, suspended forfeitures of \$404 for one month and a reprimand for being drunk and disorderly and unlawful entry.

## ARTICLE 15s

**Airman First Class: Failure to Go; False Official Statement.**

Received a reduction to E-2, suspended forfeitures of \$867 for one month, 30 days extra duty, and a reprimand for failure to go and making a false official statement.

**Airman First Class: Dereliction of Duty.**

Received a reduction to E-2, suspended forfeitures of \$867 for two months and a reprimand for dereliction of duty.

## COURTS-MARTIAL

### General Court-Martial

**Master Sergeant: Sexual Assault of a Child; Sexual Abuse of a Child x2; Child Endangerment.**

Received a dishonorable discharge, 12 years confinement, and reduction to E-1 for one specification of sexual assault of a child, two specifications of sexual abuse of a child, and one specification of child endangerment.
