### **ARTICLE 15s**

Master Sergeant: Fail to Obey Lawful Order; Make False Official Statement Received a reduction to E-6, suspended forfeitures of \$1,862 for two months, suspended 14 days extra duty and a reprimand for fail to obey lawful order and making false statement.

Senior Airman: Drunken Driving; Reckless Driving

Received a suspended reduction to E-3, forfeitures of \$1,017 for two months, and a reprimand for drunken driving and reckless driving.

Senior Airman: Destroying Non-Military Property \$500 or Less; Assault Consummated by a Battery

Received a suspended reduction to E-3, forfeitures of \$969 for two months and a reprimand for destroying non-military property and assault consummated by a battery.

Senior Airman: Dereliction of Duty Received a suspended reduction to E-3, forfeitures of \$183 for two months and a reprimand for dereliction of duty. **Technical Sergeant: Drunken Driving; Reckless Driving** 

Received a suspended reduction to E-5, forfeitures of \$1,562 for two months, 45 days extra duty and a reprimand for drunk driving and reckless driving.

Senior Airman: Larceny, Non-Military Property \$500 or Less

Received a suspended reduction to E-3, forfeitures of \$479 for one month, 14 days extra duty and a reprimand for larceny.

Senior Airman: Larceny, Non-Military Property \$500 or Less

Received a suspended reduction to E-3, forfeitures of \$183 for two months, 7 days extra duty and a reprimand for larceny.

Senior Airman: Assault Consummated by a Battery

Received a suspended reduction to E-2, forfeitures of \$617 for two months with \$617 for one month suspended and a reprimand for assault consummated by a battery.



# Don't let this happen to YOU!

Senior Airman: Fail to Obey Lawful Order Received a reduction to E-3, 14 days extra duty and a reprimand for failing to obey a lawful order.

Senior Airman: Assault Consummated by a Battery x2

Received suspended forfeitures of \$1,119 for two months, 28 days extra duty with 14 days extra duty suspended and a reprimand for assault consummated by a battery.

Senior Airman: Fail to Obey Lawful Order Received a suspended reduction to E-3, forfeitures of \$400 for two months, 30 days extra duty and a reprimand for failing to obey a lawful order.

## **COURTS-MARTIAL**

#### **General Court-Martial**

Staff Sergeant: Aggravated Sexual Assault; Assault Consummated by a Battery

This court-martial resulted in an acquittal.

#### **General Court-Martial**

Airman First Class: Fail to Obey Lawful Order; Sexual Assault of a Child x3 Received reduction to E-1, 3 years confinement and a dishonorable discharge.

#### **Summary Court-Martial**

Senior Airman: Fail to Obey Lawful Order x2

Received reduction to E-3, forfeitures of \$500 pay for one month and a reprimand for failure to obey lawful order x2.

#### **Summary Court-Martial**

Airman First Class: Attempt to Sell Military-Property \$500 or Less; Larceny Military-Property \$500 or Less x3

Received a reduction to E-1, forfeitures of \$1,031 pay for one month and 25 days confinement.
