ARTICLE 15s

Staff Sergeant: Drunk and disorderly, resisting apprehension.
Received a reduction to E-4, suspended forfeitures of \$1,027 for two months, and a reprimand for drunk and disorderly and resisting apprehension.

Staff Sergeant: Misbehavior of sentinel.
Received a suspended reduction to E-4, 14 days extra duty and a reprimand for sleeping on post.

Staff Sergeant: Fail to obey lawful order, make false official statement.
Received a suspended reduction to E-4, forfeiture of \$232 for two months and a reprimand for failing to obey a lawful order and making a false official statement.

Senior Airman: Dereliction of duty: neglect.
Received a suspended reduction to E-3, forfeiture of \$1,041 for two months, 10 days extra duty, and a reprimand for failing to remain awake while on duty. The member's suspended punishment was later vacated.

Senior Airman: Assault consummated by a battery, fail to obey lawful order, make false official statement 2 x, adultery.
Received a reduction to E-3, a suspended reduction to E-2, 45 days extra duty, and a reprimand for assault, failing to obey a lawful order, making two false official statements and committing adultery.

Senior Airman: Destroying or damaging non-military property-\$500 or less, drunk and disorderly.
Received a suspended reduction to E-3, suspended forfeitures of \$1,027 for two months, 30 days extra duty and a reprimand for damage of non-military property and for being drunk and disorderly.

Senior Airman: Dereliction of duty: willful, abusive sexual contact.
Received a reduction to E-2 and a reprimand for abusive sexual contact and dereliction of duty.

Senior Airman: Resisting apprehension, making a false official statement, assault consummated by a battery, drunk and disorderly on station.
Received a suspended reduction to E-3, forfeitures of \$1,041 for one month, suspended 45 days extra duty and a reprimand for resisting arrest while drunk and disorderly on station, committing an assault consummated by a battery, and making a false official statement.

Airman First Class: Drunken driving.

Received a reduction to E-2, a suspended reduction to E-1, 30 days extra duty, 15 days restriction, and a reprimand for driving while drunk.

Airman First Class: Drunken driving.

Received a reduction to E-2, a suspended reduction to E-1, suspended forfeitures of \$783 for two months, 14 days extra duty and a reprimand for driving while drunk.

Airman: Larceny, non-mil \$500 or less.

Received a reduction to E-1, suspended forfeitures of \$783 for two months, and a reprimand for larceny. 14 days extra duty.

Airman: Failure to go.

Received a suspended reduction to E-1, forfeitures of \$773 for two months and a reprimand for a failure to go. The member's suspended punishment was later vacated.

COURTS-MARTIAL

General Court-Martial

Staff Sergeant: Six specifications of indecent conduct, making a visual recording, one specification of assault consummated by battery, and one specification of sexual harassment.

Received reduction to E-1, total forfeitures, five years confinement, and a dishonorable discharge.
